PROFILE

I am an experienced and high achieving Consultant Clinical Neuropsychologist with extensive experience in neuropsychological assessment and rehabilitation. I have expertise in the assessment, treatment and rehabilitation of people with complex and multiple problems. I have extensive experience in medico legal work, having prepared more than 500 neuropsychological reports. I have extensive experience in the use of psychometric assessments and their application in legal contexts.

KEY SKILLS

Medico-Legal Experience

I have prepared over 500 medico-legal neuropsychological reports. These have covered the level of disability caused, suitability for rehabilitation and the determination of mental capacity.

Neuropsychology and Psychological Measurement

I have a specialisation in Clinical Neuropsychological assessment, particularly the assessment of cognitive functioning in difficult and confounded situations. I was involved in test development during my time at the University of Birmingham and as a practitioner I have specialised in Neuropsychology, applying this skill set both in dedicated neuropsychological and in generic settings. For three years I worked part time in the Regional Neurosciences Centre in Birmingham, gaining experience of neuropsychological assessment and treatment. I have experience of applying neuropsychological testing procedures in a wide variety of settings and overall I have carried out more than 1000 neuropsychological assessments.

I was, for seven years, a Consultant Clinical Neuropsychologist for the Brain Injury Rehabilitation Trust in Birmingham where I led the clinical team in a residential rehabilitation facility for people with acquired brain injuries. This team took a neurobehavioural approach to the whole of the rehabilitation process and the Trust is a leading provider of services to people who show challenging behaviour and present difficulties in their rehabilitation and require a psychologically led approach. I left to pursue more independent psychological work. This has taken the form of NPP Psychology, which is a newly created psychology component of NPP, a company which provides services in a wide range of neurological areas. I have worked for NPP as an associate for a number of years but have been recruited to develop their neuropsychology services.

Forensic Experience

I have worked in a forensic mental health setting within the NHS full time for over three years and part time in the same setting for five years. This has given me a broad and detailed experience of the legal system and its interactions with mental health mental impairment services, and has helped me to maintain and develop my role as a Registered Forensic Psychologist.

Experience in Psychological Therapy

Since I qualified as a Clinical Psychologist I have been active in delivering psychological therapy. I practise from a primarily cognitive behavioural perspective but also use techniques from other models when appropriate. I have a special interest in applying psychological therapy in residential settings and with people who suffer from cognitive impairments. I have worked with a wide range of clients including those with severe mental illness, problems in their work, marital and physical health problems, and cognitive impairment.
